### I. ESTABLISHMENT OF A QUORUM AND CALL TO ORDER

### IV. SUPERINTENDENT'S REPORT

Dr. Collins took a moment to welcome Robert J. Brule, Jr. who is replacing Jonathan King on this School Building Committee.

Dr. Collins reported that there are two corrections to the Bill List. The first item on the Bill List for Jaypro Sports is for Clark Lane Middle School and not Quaker Hill School. Also, the second from the last item on the Bill List for Crest Graphics for Waterford High School in the future will be billed to the Town of Waterford. This current bill from Crest Graphics is amended to \$3,958.36 (not \$4,195.86 which included a tax of \$237.50).

1. Access restriction agreement for Waterford High School dated November 16, 2009.

Dr. Collins explained that during the construction phase of the High School Additions and Renovations project, it will become necessary to restrict access to various corridors and exit doors. Occupancy level of the assembly spaces must be maintained at a safe level. Waterford Public Schools, Waterford High School, and Waterford Parks and Recreation Department agree that until the construction phase of the project is completed, the two gymnasiums and the auditorium will not be scheduled simultaneously for events. Paths of egress must be maintained at all times.

# VI. QUAKER HILL SCHOOL Architect's Report Quaker Hill School: Jacunski Humes Architects, LLC

Mr. Oja reported that they are continuing to prepare the LEEDS application. There were some light issues which have been resolved. There have been no complaints on the Heat Pump situation. Mr. Miner is trying to close out with CES and will need a review for the final approval. Balancing and maintaining are still being done. There are some issues with the letters on the building, pricing on the stairway into the canopy is expected soon, and the final site plan will come from BVH. The painting of the rail on Route 32 will be done soon by the maintenance staff.

### Construction Managers Report: Quaker Hill School: O & G

Mr. Giacobbe said that they will be doing a walk through with Mr. Miner on Monday. They have been doing touch up items and working on the Punch List. The Architect's final walkthrough will be done by next meeting. If we don't qualify for LEEDS Silver Certification, we may get the LEEDS Standard Certification for the building. Mr. Giacobbe stated that we are still saving money.

They are meeting with the Town Attorney on Thursday to discuss the course of action to be taken regarding the wet problem. The cupola discussions will continue at a later time.

# Construction Manager's Report, Great Neck School: O & G 1. Monthly Progress Report #6

Mr. Kotait showed slides of the construction progress at Great Neck School. The first slide was of Building A and the west elevation which showed that the masonry is complete. The edge metal on the cornice and the windows on the second floor were also shown. Building B main entrance was shown, the north elevation showed the mechanical room, administration area, and the gym. The east elevation showed the gym and the kitchen. The sky lights have been installed on Building A, and the roof will be done soon. The roof on Building A was also shown and the roof over the gym and the main entrance on Building B was shown. The electric generator has been installed. Building A interior showed the cubby room, the work room, and the computer room. Building A MEP rough in was shown, and the second floor masonry will be complete soon. The beam over the gym is ready for partitions. Building B mechanical room was shown with the big equipment installed. In the parking area, the binder course has been installed and the traffic lights have also been installed.

They are in the process of closing the building before winter. They also are installing temporary heat. The roof is almost complete. The curtain wall should be in by the end of the month. The wall panels were received today. The elevator should be here by the end of the month. Connecticut Light and Power should be here in January.
