Minutes School Building Committee Regular Meeting August 19, 2014

I. ESTABLISHMENT OF QUORUM AND CALL TO ORDER

IV. SUPERINDENDENT'S REPORT

Mr. Belair started out by acknowledging the good work being done by Mr. Miner and his staff and what a quality job Mr. Miner has been doing since O&G has wrapped up. Mr. Belair reported that they have been continuing to monitor issues with the chillers and really hope to test out the system once school starts. Mr. Belair also brought up a motion that Rudie Beers would like to have added to the agenda regarding payment to JCJ Architecture.

The committee decided to accept the Hadstedt Bros. Paving proposal for \$52,700.00 for the rear parking lot. Mr. Wilensky stated that item #4 is to activate the door by the B canopy.

Architect's Report Waterford High School: JCJ Architecture

Mr. Ayles reported that Waterford High School is currently in the LEED Silver status range and that once LEED receives payment it will take two weeks to review and there will most likely be an audit. Mr. Ayles believes that there is enough of a buffer to stay above Silver status. Mr. Ayles also informed the committee that this would be his last scheduled meeting, but that he would be available should any questions or issues arise.

Construction Report Waterford High School: Jay Miner

Mr. Miner reported that his department has started work on the auditorium lights as of 8/19, work on installing the new diving board began last week, and that the pavers were about 80% completed and should be finished by the end of the week. Mr. Miner also commented on what a nice job the Recreation and Parks Department has been doing on the lawn and shrub care around the campus, but he's noticed that some of the trees in the courtyard are not doing so well and he asked that Mr. Ayles take a look. Mr. Miner added

that work on irrigation of the fields will begin next week and that the directional signs will be put in place Wednesday morning.
